The Adva Center A Valuable Asset for Israel

The Adva Center is a think tank that analyzes social and economic issues and makes policy recommendations; it also engages in advocacy work and public education to increase the chances that its recommendations will be adopted.

The Adva Center measures public policies in Israel against the yardsticks of equality and social justice. Without Adva, the trend of increasing inequalities between rich and poor, Jews and Arabs, center and periphery in education, health and wages would continue unchallenged and unabated. Without Adva, women's needs would not be translated into budget allocations and the most disadvantaged social groups in Israel – Ethiopian Israelis and Bedouin Israelis – would lack a strategic advocate. Without Adva, the phenomenon of increasing numbers of workers with low wages and inadequate social security would receive less public attention

The Adva Center played a pivotal role in the framing of issues that have become central to the Israeli public discourse; for example, the connection between economic growth and the alleviation of social ills. Adva demonstrated that economic growth does not necessarily benefit those who need it most. Another example: the fact that the Israeli educational system does not turn out the man and woman power needed for an advanced economy. Yet another: while the Israeli public health system is very good in comparative terms, it is slowly losing its edge, as a result of under-financing. Finally, the fact that economic development has been taking place primarily in the center of the country, sidelining peripheral areas, minority groups, and middle and low-tech industries and services.

Advocacy work, including consultations for Cabinet ministers, executive officials, legislators and leaders of advocacy organizations;

Creation and provision of leadership for the Women's Budget Forum, a coalition of 30 women's and human rights organizations that advocate for women's fair share of the national budget;

Popular education, through lectures, seminars and courses - among them economic literacy courses for women;

Affirmative action scholarship program for Arab women who are citizens of Israel;

Projects designed to assist low-income persons to realize their social rights;

User-friendly web site, where all Adva reports and position papers are downloadable free of change, hosting 1,000 visitors a day;

Media work, including provision of background information to the written and electronic media on topics of public interest.

..."The basic problem is that economic growth has been very uneven," said Shlomo Swirski, the academic director of Adva, a research institute that focuses on the poor. Job growth, he said, has been concentrated in sectors that require a high level of education. Economic growth has been greatest in Tel Aviv and surrounding areas, the economic hub of the country, while the less developed Galilee in the north and Negev Desert in the south have seen much less progress, Mr. Swirski added.

Concerning legislation:

Changes in the national budget-making process;

Reduction of the Budget Arrangements Law, an undemocratic way of passing legislation;

Changes in the 2008 budget, including non-passage of legislation that threatened the universality of the public health system, non-passage of legislation that would have imposed health and social security taxes on housewives with no incomes, and the reinstatement of social security cuts made in 2002.

Concerning training:

Economists, sociologists and public policy experts who work at Adva take what they have learned at Adva to academia, government, and business;

For the last three years, The National Security College has invited Adva staff members to present lectures to senior IDF officers and government officials;

Adva publications have become standard reading for students of Political Science, Public Policy, Sociology and Social Work.

...An informal coalition of MKs, patient groups and other organizations has been formed to fight the sections of the Treasury's Arrangements Bill

that threaten to increase the inequality in the health system and make it even more difficult for disadvantaged groups to get decent medical care.

Six Knesset members, led by MK Haim Oron, appeared Tuesday at the special meeting initiated by the Adva Center (Information on Equality and Social Justice in Israel) and Physicians for Human Rights-Israel. The two-hour event was held in the Knesset lecture hall. ...Among the health-related clauses, said Adva Center Director Barbara Swirski, were: procedures that will increase the gap between new medical technologies and those included in the basket of health services ... and the plan to establish a fifth health fund that opponents predict will siphon off wealthy, young and healthy members from the four health funds.

Among Adva's products and activities in 2007:

24 budget reports and position papers on budget issues, distributed to Cabinet members, legislators, executive officials, advocacy organizations and the mass media;

4 special Adva-initiated Knesset sessions on the proposed 2008 budget;

annual Adva budget workshop for legislators;

annual Adva conference on budgets and gender;

6 reports and policy analysis papers, on the following issues: the right to higher education in Israel, the right to work in Israel, the absence of plans to significantly improve the situation of the Bedouin in the Negev, threats to the public health system, a recent pension agreement, and the health and social security situation of senior citizens.

3 pamphlets on social rights and budgets in Israel, in both Hebrew and Arabic, for use in the educational activities of Adva and of other organizations;

2 economic literacy courses for women;

100 educational events on a variety of topics, all of them connected with equality and social justice;

1 scholarship for an Arab women to earn a Master's Degree in Economics abroad;

15 appearances in the written media per month and 80 appearances on TV, radio and internet news. Adva's Budget ____ANALYSISPENSIO and Staff

The Adva Center has a small staff of 8-10 professionals, not all full-time, and a modest budget of about \$400,000. Due to the amount of work Adva does and the amount of publicity it gets, Israelis tend to think that it is much bigger than it actually is.

Adva's Development Plans

The work of the Adva Center is critical for Israeli society.

Israel's middle class is continuing to shrink, and it

currently encompasses only about one-fourth of all households, down from onethird in the late 1980s, according to a report issued yesterday by the Adva Center.

The report, based on income surveys conducted by the Central Bureau of Statustics between 1988 and 2005, also found that the middle class' share of the national income has fallen by 20 to 24%.

The study noted that the size of the middle class has great significance, both because this is what most people consider "normal" and because the middle class is generally considered the economy's backbone, both as workers and as consumers.

...The policy of social growth must be goal-based just like the policy of economic growth; for example, increasing the percentage of (high school graduates receiving) matriculation certificate to 80 percent (similar to the goal that France has set for itself), increasing the proportion of students in academic institutions to 60 percent of each cohort of high school graduates (instead of the 30 percent today) and the full funding of the basket of health services that will halt the splitting of the health system into a system for the wealthy and a system for ordinary folk. The policy that has been followed thus far, which has left all of the work in the hands of the market forces, ultimately strengthens those who have power in the marketplace and weakens all the rest.

Experts say that certain budget cuts will damage the status of women.

...A government proposal to levy taxes on housewives as part of the 2008 Economic Arrangements Bill was harshly criticized and potentially stopped Wednesday during a joint session of the Knesset Committees of Finance and the Status of Women, with politicians calling for that element of next year's budget to be immediately removed.

"We are feeling positive that this tax will not come into effect for the forthcoming year," Valeria Seigelshifer, an advocate at the Adva Center for Equality and Social Justice in Israel, told The Jerusalem Post. following the meetings. ..."We want to make clear that cuts in child support are also harmful to our children," added Seigelshifer, highlighting that the postponement of increasing the minimum wage which was scheduled to have happened in June 2007 but will now take place next summer, also impacts the female population because two-thirds of those earning low salaries are women.
